Joe Backmeyer mentioned that the newsletters were very well prepared and thanked the Knightstown staff for clearing the snow and keeping our staff safe. He also told everyone about the transition team formed to help with decisions in preparing to close Kennard and Carthage Elementaries. He said this team was made up of our building administrators, food service director,

technology director, transportation director, athletic director, school nurse and himself. He told how after each meeting he will send a summary of each meeting to the staff and school board members so they will know what took place. He also had a facility transition calendar of the process that will be taking place month by month and discussed the ideas that will be taking place as we move forward in closing Kennard and Carthage.

6.01 Wavier of Instructional Days

Joe Backmeyer tells that we have been granted the wavier for one day, but we have several days to make up. The days we have already made up are Martin Luther King Day, Jan. 7th and President's Day, Feb. 17. Also, we are scheduled to make up 4 days the 1st week of Spring Break, which will leave us 3 other days to make up. The Indiana Dept. of Education has provided a wavier which we can apply for if the corporation determines we can restructure our school day to make up for the loss of instructional time. He tells about the all call sent out to parents about the survey on the website and the responses sent by email to building principals and himself. He tells about a schedule of adding 20 minutes over a period of 54 days. Students would be picked up at the same bus schedule; they would just simply have a 20 minute longer day with buses picking them up 20 minutes later for the afternoon trip home. The board discussed the responses and Jed Behny told how the 20 minutes would be applied at his building. It was noted that winter was not over yet and there may still be the need to use days at the end of the school year. At this point we are still out 4 days before graduation.

Kevin Knott motioned to approve the Resolution for the Conditional Wavier of Penalty for the Loss of Instruction Days with a modified school calendar. Gerald Leonard seconded the motion and the motion carried 6-0.

Joe Backmeyer explains that Jed Behny has put a lot of time into the Secured Schools Safety Grant Program. Jed Behny explains the grant program and how it affects our schools. Brian Woods also answered questions. After much discussion, Wade Beatty motioned to apply for the maximum \$100,000.00 for the School Safety Grant. Don Scheumann seconded the motion and the motion carried 6-0.

Joe Backmeyer tells of the letter from the Knightstown Chamber Of Commerce inviting the School Corporation to become a member. Mr. Backmeyer said there is a membership fee of \$25 for the school Corporation. Wade Beatty motions to join the Knightstown Chamber of Commerce. Gerald Leonard seconds the motion. The motion carried 6-0.

Stephanie Madison explains the Emergency Allocation needed for an electrical issue after a storm at Kennard Elementary. The allowance is \$20,000.00 for the year. The Emergency Allocation would be for \$5000 to pay our insurance deductible. Wade Beatty motioned to use \$5000 out of the Emergency Capitol Projects Fund to cover the deductible of the damage at Kennard Elementary. Tom Schaetzle seconds the motion and the motion carried 6-0.

Wade Beatty tells about the added items. He tells of the Governor's plan to eliminate the Business Personal Property tax. He notes that the loss to the Corporation could be \$200,000.00. Gerald Leonard motions to approve the Resolution to appose the Business Personal Property Tax Elimination. Kevin Knott seconds the motion and the motion carried 6-0.

Wade Beatty explains the next added item. He explains that in the January meeting the board tabled making an appointment to the Parks and Recreational Board until they were able to get more information. He said that the person does not have to be a school board member. Clyde South, Town

Board President contacted Mr. Beatty and recommended Anna Wyatt to be appointed to the Parks Board. It would be just as the appointment to the Library Board. After much discussion Kevin Knott motioned to appoint Anna Wyatt to the Parks and Recreational Board for one year. Tom Schaetzle seconded the motion and the motion carried 6-0.
